OF 10 3/4" 36 POUND SURFACE CASING AND 1500 FT. OF 7 inch casing about 24 POUND. WE PROPOSE TO CLEAN OUT THE OLD HOLE AND RUN 10 3/4" IN ON A 7" TO 4 1/2" PACKER TO TEST. 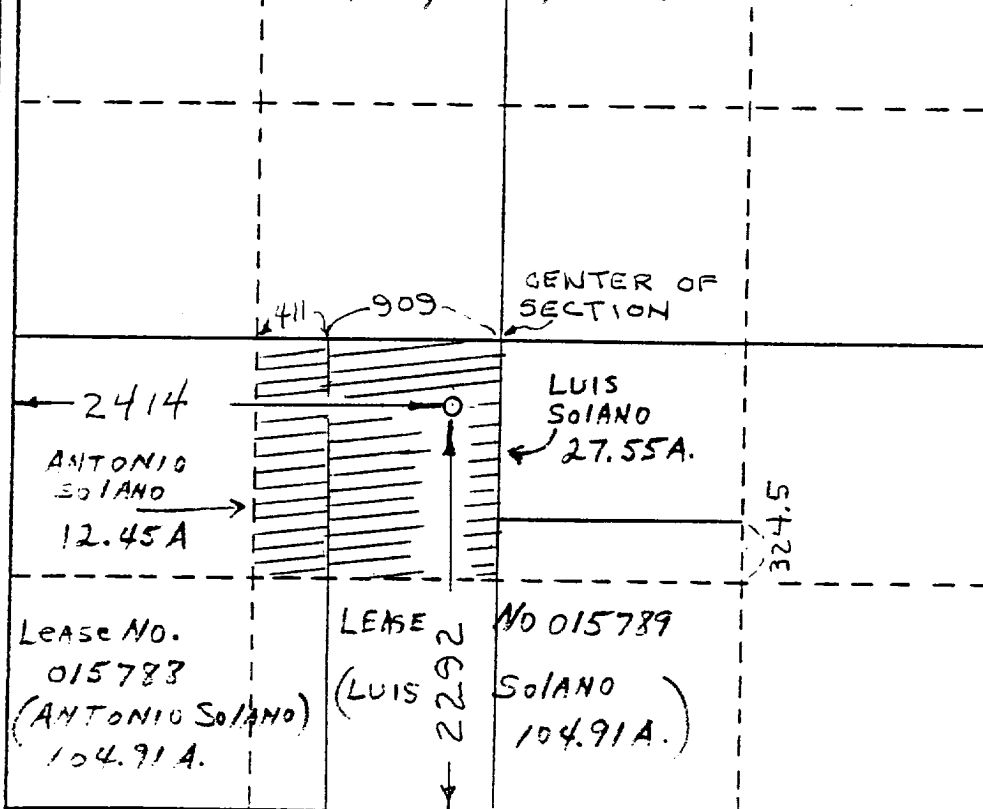
