IF WE DON'T HAVE A PRODUCER, WE WILL PLUG THE WELL AS INSTRUCTED.

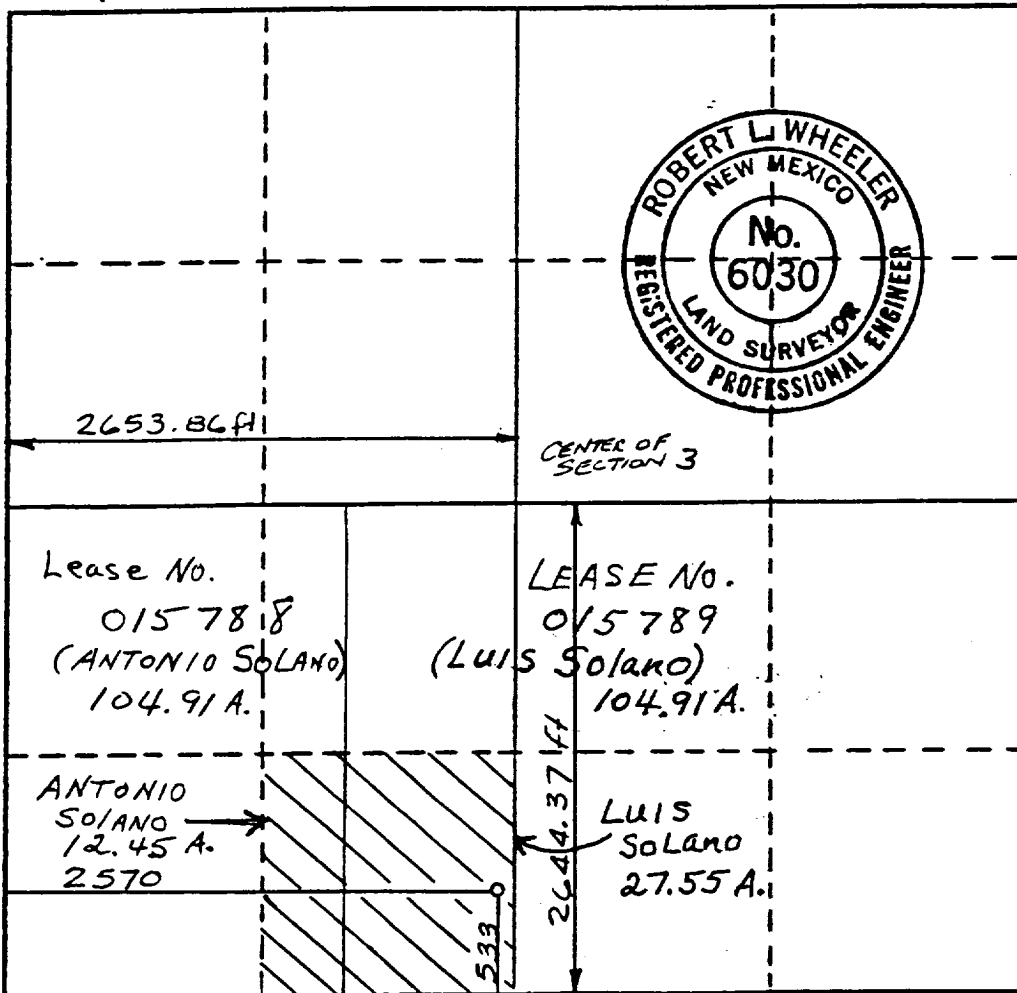
