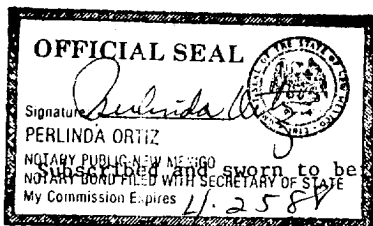
3. That said well was drilled to a total depth of 1,140' feet, and that cas-

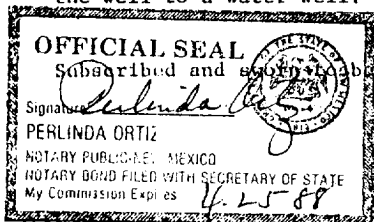

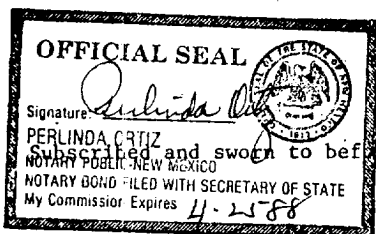

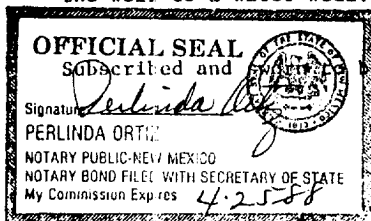
