FULL DETAILS OF PROPOSED PLAN OF WORK
(FOLLOW INSTRUCTIONS IN THE RULES AND REGULATIONS)

Propose to plug well as follows:

1. Fill annular space between 12 1/2 surface pipe and hole with cement.
2. Pull 8 5/8" casing
3. Set 40' cement plug across the bottom of surface pipe (from 258'-298')
4. Set 10' cement plug at surface with 4" diameter marker 4' above surface.

(If 8 5/8" casing cannot be pulled, we intend to cement the annular space between the 8 5/8" and 12 1/2" casing as well as place a 40' cement plug inside the 8 5/8" casing.)
