Gentlemen:

Mr. J. E. Kapteina, the Commission's District Engineer in the Santa Fe office, has formulated the following plugging program which must be complied with in plugging the subject well:

Place cement plug from total depth (approximately 5105 feet) to 4600 feet, using 60 sacks of cement.

Fill the hole with heavy plugging mud.

Place a cement plug from 600 feet to 550 feet, using 20 sacks of cement.

Place a 10-sack cement plug at the surface with a four foot regulation marker set in the top of the plug.

The Commission will expect the subject well to be plugged in accordance with the plugging program set forth above by October 1, 1961. Please consider this letter a firm demand on the Maryland Casualty Company, as surety on the subject bond, to have the plugging accomplished by this date. Mr. Kapteina must be given notice forty-eight hours in advance of the commencement of the
