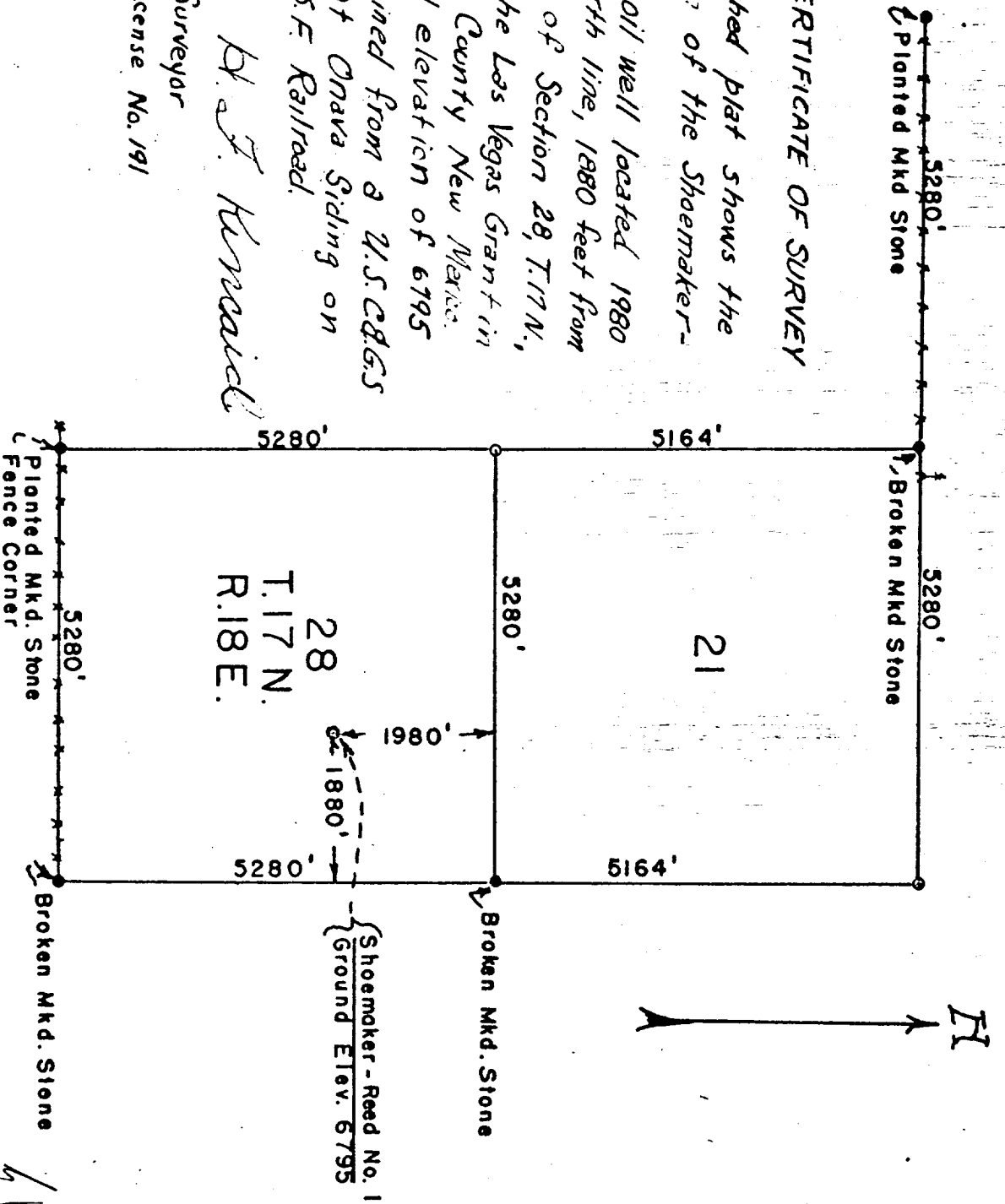
CERTIFICATE OF SURVEY

The attached plat shows the true location of the Shoemaker-

Reed No. 1 oil well located 1980 feet from the north line, 1880 feet from the east line of Section 28, T.17 N., R.18 E. on the Las Vegas Grant in San Miguel County New Mexico. The ground elevation of 6795 was determined from a U.S. C&GS benchmark of Onava Siding on the A.T.&S.F. Railroad.
