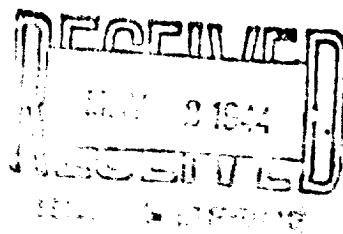

DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

Well was cleaned out to bottom of 8 1/4" pipe, bridged with wooden plug and sand and gravel then dumped ten sacks of cement, then filled hole with heavy mud to bottom of 13 3/4" pipe, there set a bridge of wooden plug and sand and gravel and dumped 15 sacks of cement. Filled hole with heavy mud to surface, set 4' regulation marker in cement to extent of 4' above the ground.
