We intend to temporarily plug and abandon this well. In accordance with our conversation with you, we will place a 50 sack cement plug across the bottom of the shoe of our 4-1/2" casing at 2360', and a 10 sack surface plug in the casing. If we do not re-enter this well, it will be ready for surface marker and permanent abandonment as discussed with you.
