We have drilled a 12-1/4" hole and ran 8-5/8" casing to 200'. We cemented the casing to the surface. The well was spud February 10th, 1986. We subsequently drilled a 7-7/8" hole to 3536', then changed to a 6-14/" hole and drilled to T.D. at 4252'. No oil or gas zones were encountered. We will log and plug and abandon this well.

We wish to change our hole size by drilling a 12-1/4" hole to 200' and running 8-5/8" 24# casing to 200'. We will then drill a 7-7/8" hole or smaller to T.D. We intend to drill with a down-hole motor to keep the hole straight. We will cement our surface casing from 200' to surface. In the event oil or gas is encountered, we will run 4-1/2" casing and attempt a completion as appropriate.
