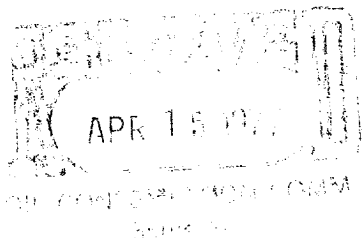

- (2) A steel marker to be placed 4' above ground level.
- (3) Loc to be cleared of all junk and pits filled and loc to be leveled.
