Well was drilled to 9379'. Verbal permission to P. & A. was granted by Mr. Carl Ulvog on Mar. 24, 1977 - N. Mexico Conservation Comm. Plugging operations were begun on Mar. 24, 1977 and the well was plugged as follows:

- 30 sx cmt placed at 2000-1916' (9# mud)
- 30 sx cmt placed at 1700-1666' (9# mud)
- 25 sx cmt placed at 510-440' (9# mud)
- 10 sx cmt placed at surface w/dry hole marker.

The surface casing (490' of 9 5/8" 36# K-55 ST&C) was left in hole. All pits were filled and the location leveled and cleared of all junk.* Well was marked by steel marker placed in concrete and extended 4 ft. above ground. Plugging operations were completed on Mar 24, 1977 and Loffland Rig #12 released.

*The pits were filled and the location leveled and cleared of all junk on 4-15-77.
