1. We propose to re-enter the Hattie Lacy #1 to continue drilling to Granite +100'. We bottomed in Granite Wash due to rig limitations.
 2. We propose to begin this re-entry approximately May 1, 1993, after the completion of our proposed Chupadera #1 well in Sec. 23-3S-6E.
 3. We propose to use the existing surface pits, casing and roads.

4. Our 3-17-93 request wasn't approved until Aug. 31, 1993, and by that time our rig that drilled Chupadera #1 wasn't available. (Rig released May 1, 1993)
 5. Also, the farmout from Yates Petroleum to drill Chupadera #2 and re-work Chupadera # 1 was 8 months getting approved, thus our 1994 schedule is messed up.
