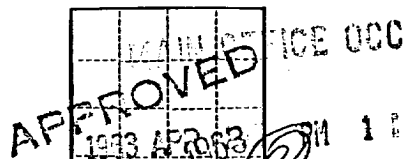

DETAILS OF WORK

This well was drilled to total depth of 3037 feet with no commercial show of oil or gas. 10-3/4" surface casing set and cemented at depth 238 feet. 5" casing set at 2710 feet with 275 sacks. Propose to plug and abandon by filling hole with heavy mud and placing cement plugs as follows:

20-sack plug at depth of 2650 feet

15-sack plug at depth of 1440 feet

20-sack plug in stub of 5" casing if any of casing is pulled

20-foot plug at depth of 20 feet

Erect regulation well marker.

This is to confirm oral approval to plug given April 3, 1963.

I understand that this plan of work must receive approval in writing by the Geological Survey before operations may be commenced.
