Well drilled to depth of 2008 feet, penetrated top of Madera (Penn) at 1871 feet. Set 200' of 7 5/8 surface casing, cemented by National Cementers Corporation.

Filled from bottom to within 20 feet of surface with mud. Last 20 feet below surface filled with cement made into concrete with 4 inch pipe placed in center and protruding four feet above ground surface.

Future plans of deepening to 3000' or granite, to test Penn formation.
