M. A. Romero, being first duly sworn according to law, upon his oath deposes and says:

1. That he is operator of Sam Sahw No. 2,

2. That M.A.ROMERO is the operator of a well drilled on land be-

longing to Sam Shaw, whose address is Mountainair, NM

M.A.ROMERO, said well being drilled to test for hydrocarbons and/or carbon dioxide gas and described as the Sam Shaw No. 2, being located 535 feet from the East line and 337 feet from the South line of Section 13, Township 4 N, Range 7E, NMPM, County, New Mexico.

3. That said well was drilled to a total depth of 2842 feet, and that casing has been set and cemented as follows:
Plugged with cement from bottom to 1900 feet. 4½ A.P.I 12lb per foot pipe was set at 1900 feet. Well started with 8" surface casing (206 feet) Cemented by National Cementers, Grants, NM. with 50 sacks.

4. That operator and landowner have made an agreement whereby operator (is) (is not) to back fill pits, level location, and clear it of all junk. The agreement further provides that operator is to plug said well back to a plugged-back total depth of 1890' feet and transfer well to landowner for his use as a water-well. Operator will leave casing in the well as follows:
1890 feet of 4½ A.P.I. 12 lb Pipe

That when operator has complied with the provisions of Paragraph 4 above it will so notify the Oil Conservation Division of the State of New Mexico on Division Form C-103, together with a signed statement from the landowner that the provisions of Paragraph 4 above have been complied with to his satisfaction,
