Well spudded in Nov. 29, 1979. 206' of 8" Round set 30 sacks, as surface Casing.
Drilled to depth of 1850. On Dec. 9th 1979 Schlumberger logged well to 1842 feet.
Drilling resumed on Dec. 11th and well carried to total depth of 2841 feet.
On Dec. 22nd 1979 Schlumberger logged well to 2820 feet.
On Dec. 23 National Cementers Corp. Grants, NM, plugged with 70 sacks from 2820 to 2420, and used 65 sacks from 2420 to 1940 feet.
Dec. 27 4½, 12lb casing was set at 1900', and cemented by National Cementers Corporation.
Dalton Logging and Perforating Co., Grants, NM., logged before perforating zones showing promise of oil or gas.
As of today we are testing by bailing and probably swabbing.
