On 6/10/86 layed down tubing and rods. Placed 60' oc cement from 2287' to 2227' on existing bridge plug. Set 4½' cast iron bridge plug at 2050', and placed 60' of cement to 1990'. Set 4½' cast iron bridge plug at 1300' on 6/11/86. Placed 60' of cement to 1240'. Set 4½' cast iron bridge plug at 318'. Split 4½" casing at 303' to cement across 8 5/8" casing. Placed 90' of cement to 228'. Placed cement retainer and 50' of cement at surface. Welded cap and placed permanent well marker.
