Shoot off 7" casing at about 2300' pull, and plug and abandon the well as dry. Set cement plug from 362' to 385', just below the 16" surface casing, leave the surface casing open from surface to 362' for a water well for the Berkshire Bros. The Berkshire Bros. requested this procedure so they would be able to rip the surface casing for a water well.
