DETAILED ACCOUNT OF WORK DONE AND RESULTS OBTAINED

The 4" casing was landed at 1940'. Halliburton cement co. did the work using 40 sacks of cement.
The 3" casing was landed at 2369'. Halliburton cement co. did the cementing using 35 bbl cement. On the second attempt of a squeeze the job 60 bbl of cement was used. Could not squeeze same and the cement set up plugging the casing to within 1000' of surface.
