Kapteina and plugged and abandoned as follows: Spotted 47 sack cement plug No. 1 from 3838' to 3677'; 40 sack cement plug No. 2 from 1825' to 1685'; 13 sack cement plug No. 3 from 347' to 327', across 8-5/8" shoe at 337' and 10 sack cement plug No. 4 from 30' to surface. Installed dry hole marker. Plugged and abandoned April 5, 1970
