Propose to kill well, release packer and pull out of hole tubing and packer. Run in hole with bit and tubing. Clean out well to plug back total depth. Perf intervals 2238-2368. Run in hole with 1 jt 2-3/8 tailpipe, packer, sand and 2-3/8 tubing. Set and test packer. Swab well and stimulate with 24 tons liquid CO2. Flow test well overnight and return well to production.
