Workover to check tubing and packer for leak. Moved in service unit 2-14-84. Dropped standing valve and pressure tested tubing 2000 psi and fell off to 1550 psi for 30 min and held OK. Pressure tested casing held OK. Unset packer, pulled 1 jt. tubing, and packer set at 2224'. Tailpipe landed at 2261'. Loaded backside with 35 bbl packer fluid and pressure tested casing to 500 psi and tubing to 2500 psi. Casing pressured up to 540 psi and tubing pressure remained the same for 30 min. Ran sand line & fished out standing valve. Moved off service unit 2-16-84 and shut well in.
