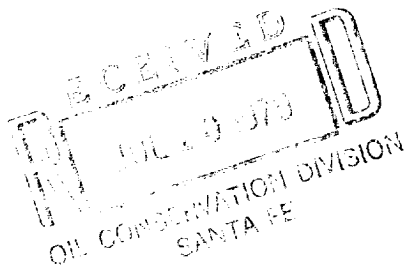

On 6-27-79 Sitton Drill Co. (Rig. #1) spudded a 12 1/4" hole at 5:30 P.M. Drilled to a TD of 369' and ran 8 5/8 24# casing set at 369'. Cemented with 200 SX Class C cement with 2% KCL. Circulated 12 SX. Plug down at 2:15 A.M. 6-28-79. WOC 18 hrs. Tested casing with 1000# for 30 min. Test OK. Reduced hole to 7 7/8" and resumed drilling.
