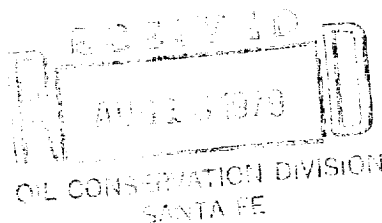

Drilled to a TD of 2625' and ran 4-1/2" 9-1/2# casing set at 2624'. Cemented with 900 SX Class C cement with additives. Plug down 5:15 p.m. 7-16-79. Cement did not circulate. Temp survey found top of cement at approx. 764' from surface. WOC 18 hrs. Tested casing with 1000# for 30 min. Test OK. Currently waiting completion unit.
