On 7-19-79 Sitton Drilling Co. (Rig #1) spudded a 12-1/4 hole at 12:00 midnight. Drilled to a TD of 360' and ran 8-5/8" 24# casing set at 360'. Cemented with 200 SX Class C cement with 2% CACL. Plug down 6:15 a.m. 7-20-79. Circulated 25 SX. Woc 18 hrs. Tested casing with 1000# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling.
