Set packer at 1973' and pressure tested 1000 psi-ok. Opened well to transport and recovered 10BBLS. Stimulated with 30 tons CO₂. Flowed well to transport overnight. MOSU 8-12-85 and returned well to production. Work completed 9/2/85.
