Perforated 2236-52', 2254-42', 2268-83', 2284-2309', 2310-44', 2346-53', 2356-82', 2420-38' with 2 SPF. Left well open to tank overnight. Re-ran production equipment. Tubing landed at 2023' and packer set at 2042'. Pressure tested casing 1000psi - ok. Swabbed 15 BW. Stimulated with 25 Ton CO₂ and 480 ball sealers. MOSU 7-9-85 and returned well to production. Operations completed 8-13-85. PAWD: 1617 MCFD.
