Drilled cement to 1072'. Drilled to a TD of 2545' and ran 5-1/2" casing set at 2545'. Cemented with 775 SX Class H cement. Plugged down 3:30 p.m. 2-22-81. Circulated 227 SX. Currently waiting on completion unit.
