Propose to kill well and release packer and pull out of hole tubing and packer. Run in hole with bit and tubing. Clean out well to plug back total depth. Perf intervals 2170-2370. Run in hole with 1 jt 2-7/8 tubing, packer sand and 2-7/8 tubing. Swab well and stimulate with 34 tons liquid CO2. Flow test overnight and return well to production.
