Moved in service unit 4-16-82. Pulled tubing. Perforated 2123'-29', 36'-47', 63'-89', 95'-2219', 23'-28', 31'-46', 85'-87', 90'-2302', 07'-17', 20'-23', and 26'-30' with 1 JSPF. Ran packer and 3-1/2" tubing. Set packer at 612'. Fractured with 21000 gal 40# x-linked gel with additives and 23000# 8/12 sand. Pulled tubing and packer. Cleaned out sand 2247'-2340' with sand pump. Ran 2-3/8" tubing and seating nipple with tubing landing at 2061'. Moved out service unit 4-22-82. Turned well thru a separator on 4-25-82 and flow tested for 164 hrs. Well flowed 9675 MCF and 33 BLW. Ran 72 hr. BHP buildup test 4-30-82 thru 5-3-82. Well shut-in.
