Moved in service unit 2-24-82. Pulled tubing and seating nipple. Perforated 2220'-27', 39'-52', 56'-66', 79'-90', 97'-2302', 16'-18', 27'-33', 56'-68', 72'-92', and 2405'-21' with 1 JSPF. Ran packer and tubing. Set packer at 597'. Fractured well with 19320 gal 40# x-linked gel with additives and 2000# 8/12 sand. Pulled tubing and packer. Tagged sand at 2205' with 426' of fill. Cleaned out sand to 2497'. Ran seating nipple and tubing. Landed tubing at 2154'. Ran swab with slight show of gas. Moved out service unit 3-4-82. On 3-7-82 turned well thru a separator and flow tested for 173 hrs. Well flowed 5445 MCF and 52 BLW. Ran 72 hr. BHP buildup test 3-12-82 thru 3-15-82. Well shut-in 3-15-82.
