Moved in service unit 4-15-82. Pulled tubing, Perforated 2178'-83', 89'-2200', 12'-51', 64'-91', 95'-98', 2310'-14', 24'-28', 36'-46', and 54'-59' with 1 JSPF. Set a packer at 610'. Fractured well with 21000 gal 40# x-linked gel with additives and 23000# 8/12 sand. Pulled packer. Cleaned out sand 2296'-2404' with sand pump. Ran 2-3/8" tubing and seating nipple. Tubing landed at 2113'. Moved out service unit 4-21-82. On 4-22-82 turned well thru a separator and flow tested for 160 hrs. Well flowed 12716 MCF and 17 BLW. Ran 72 hr. BHP buildup test. 4-29-82 thru 5-2-82. Well shut-in.
