On 1-28-81 Moran Drilling (Rig #52) spudded a 12-1/4" hole at 4:15 p.m. Drilled to a TD of 705' and ran 8-5/8" casing set at 705'. Cemented with 500 SX Class H cement. Plugged down at 5:15 p.m. 1-29-81. Circulated 170 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole 7-7/8" and resumed drilling. Drilled to a TD of 2597' and ran 5-1/2" casing set at 2597'. Cemented with 825 SX Class H cement. Plugged down 10:00 a.m. 2-4-81. Circulated 180 SX. Currently waiting on completion unit.
