On 2-3-81 Moran Drilling (Rig #56) spudded a 12-1/4" hole at 6:00 p.m. Drilled to a TD of 743' and ran 8-5/8" casing set at 743'. Cemented with 500 SX Class H cement. Plugged down at 7:30 p.m. 2-6-81. Circulated 100 SX. WOC 18 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2631' and ran 5-1/2" casing set at 2631'. Cemented with 850 SX Class H cement. Plugged down 5:30 a.m. 2-24-81. Circulated 180 SX. Currently waiting on completion unit.
