Killed well and re-ran production equipment. Tubing landed at 1946' and packer at 1915'. Pressure tested casing and packer 1000 psi - ok. Stimulated with 24 Tons CO₂. MISU 9-27-85 and returned well to production. Operations completed 10/23/85.
