On 3-22-81 CO2 in Action (Rig #19) spudded a 12-1/4" hole at 7:05 p.m. Drilled to a TD of 702' and ran 8-5/8" casing set at 702'. Cemented with 500 SX Class H cement. Plugged down 9:00 a.m. 3-24-81. Circulated 160 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3645' and ran 5-1/2" casing set at 3645'. Cemented with 670 SX Class H cement. Plugged down 11:00 p.m. 4-1-81. Circulated 330 SX. Currently waiting on completion unit.
