On 3-17-81 CO2 in Action (Rig #18) spudded a 12-1/4" hole at 6:30 p.m. Drilled to a TD of 666' and ran 8-5/8" casing set at 666'. Cemented with 500 SX Class H cement. Plugged down 1:30 p.m. 3-18-81. Circulated 120 SX. WOC 20 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2727' and ran 5-1/2" casing set at 2726'. Cemented with 850 SX Class H cement. Plugged down 10:00 p.m. 3-26-81. Circulated 110 SX. Currently waiting on completion unit.
