Moved in service unit 6-30-81. Pulled tubing. Ran packer and tubing. Set packer at 1924'. Fractured with 20000 gal. 40# gel x-linked 2% KCL water and 23500# 8/12 sand tagged with radioactive material. All perfs took frac. Pulled tubing and packer. Ran seating nipple and 2-7/8" tubing landed at 2097'. Moved out service unit 7-6-81. Flow tested for 168 hrs. and flowed 13227 MCF and 173 BLW with an average of 1890 MCFD. Ran 72 hr. BHP buildup test. 7-10-81 thru 7-13-81. Moved in service unit 7-16-81. Pulled 2-7/8" tubing. Ran 2-3/8" tubing and seating nipple. Seating nipple set at 2080'. Moved out service unit 7-17-81. Well shut-in 7-17-81.
