On 4-20-81 Moran Borthers (Rig #56) spudded a 12-1/4" hole at 1:00 p.m. Drilled to a TD of 740' and ran 8-5/8" casing set at 740'. Cemented with 500 SX Class H cement. Plugged down 10:00 a.m. 4-21-81. Circulated 135 SX. WOC 18 hrs. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2802' and ran 5-1/2" casing set at 2801'. Cemented with 750 SX Class H cement. Plugged down 6:45 a.m. 4-26-81. Circulated 242 SX. Currently waiting on completion unit.
