On 3-17-81 Royal Drilling (Rig #1) spudded a 12-1/4" hole at 9:00 p.m. Drilled to a TD of 707' and ran 8-5/8" casing set at 707'. Cemented with 500 SX Class H cement. Plugged down 2:05 a.m. 3-19-81. Circulated 100 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2525' and ran 5-1/2" casing set at 2525'. Cemented with 1000 SX Class H cement. Plugged down 9:00 a.m. 3-23-81. Circulated 250 SX. Currently waiting on completion unit.
