On 3-15-81 Swanson Drilling (Rig #3) spudded a 12-1/4" hole at 12:01 p.m. Drilled to a TD of 708' and ran 8-5/8" casing set at 708'. Cemented with 500 SX Class H cement. Plugged down 4:30 a.m. 3-16-81. Circulated 140 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2552' and ran 5-1/2" casing set at 2552'. Cemented with 750 SX Class H cement. Plugged down 6:30 a.m. 3-21-81. Circulated 243 SX. Currently waiting on completion unit.
