7. Describe Proposed or Completed Operations (Clearly state all pertinent actions, and give pertinent dates, including estimated date of starting any proposed work) SEE RULE 1103.

Move in, rig up service unit 4-17-85. Kill well with 20 bbl water with 2% KCL. RT and IB and release packer. PU 2-3/8 tubing, Guiberson Uni VI packer and perf 2134-44, 2148-66, 2189-2200, 2202-74 with 2 SPF. Run 1 jt fiberglass tubing, Guiberson Uni VI packer, seating nipple and 2-7/8 tubing. Tailpipe landed at 1974' and packer set at 1943 ft. ND BOP and disp casing with 32 bbls inhibited packer fluid. Seating nipple set at 1936 ft. Pressure test packer to 1000 psi and ok. Run swab and stim with 22 tons CO2 and 469 ball sealers. Rig down move out service unit 4-23-85.

Returned well to production.
