On 3-3-81 Salizar Drilling (Rig #13) spudded a 12-1/4" hole at 10:30 a.m. Drilled to a TD of 708' and ran 8-5/8" casing set at 708'. Cemented with 500 SX Class H cement. Plugged down 6:45 p.m. 3-4-81. Circulated 240 SX. WOC 18 hrs. Tested casing with 800# for 1 hr. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2597' and 5-1/2" casing set at 2597'. Cemented with 725 SX Class H cement. Plugged down 10:00 a.m. 3-9-81. Circulated 234 SX. Currently waiting on completion unit.
