On 2-22-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 9:30 a.m. Drilled to a TD of 673' and ran 8-5/8" casing set at 673'. Cemented with 500 SX Class H cement. Plugged down 7:00 p.m. 2-23-81. Circulated 190 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2735' and ran 5-1/2" casing set at 2730'. Cemented with 930 SX Class H cement. Plugged down 10:00 p.m. 3-1-81. Circulated 240 SX. Currently waiting on completion unit.
