On 2-23-81 C02 in Action (Rig #18) spudded a 12-1/4" hole at 6:00 p.m. Drilled to a TD of 709' and ran 8-5/8" casing set at 705'. Cemented with 500 SX Class H cement. Plugged down 3:00 p.m. 2-24-81. Circulated 90 SX. WOC 19 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2586' and ran 5-1/2" casing set at 2586'. Cemented with 900 SX Class H cement. Plugged down 7:00 p.m. 3-3-81. Circulated 225 SX. Currently waiting on completion unit.
