On 3-16-81 James Drilling (Rig #7) spudded a 12-1/4" hole at 7:00 p.m. Drilled to a TD of 700' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down 2:30 a.m. 3-18-81. Circulated 180 SX. WOC 19 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2615' and ran 5-1/2" casing set at 2615'. Cemented with 800 SX Class H cement. Plugged down 8:15 a.m. 3-27-81. Circulated 235 SX. Currently waiting on completion unit.
