Killed well and RIH with packer and tubing. Tubing landed at 2049' and packer set at 2018'. Pressure tested casing and packer 1000 psi-ok. Left well open to tank over night. Stimulated with 20 tons CO₂ and 280 ball sealers. MOSU 6-28-85 and returned well to production.
