Propose to kill well, release packer and pull out of hole tubing and packer. Run in hole with bit and tubing and clean out well to PBTD. Perf 2176-2266. Run in hole 2-7/8 tailpipe, packer, sand and 2-7/8 tubing to surface. Set and test packer. Swab well and stimulate with 20 tons liquid CO₂. Flow test overnight and return well to production.
