On 3-28-81 CO2 in Action (Rig #18) spudded a 12-1/4" hole at 1:00 p.m. Drilled to a TD of 700' and ran 8-5/8" casing set at 700'. Cemented with 500 SX Class H cement. Plugged down 10:30 a.m. 3-29-81. Circulated 32 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 2650' and ran 5-1/2" casing set at 2650'. Cemented with 990 SX Class H cement. Plugged down 10:30 p.m. 4-3-81. Circulated 125 SX. Currently waiting on completion unit.
