On 3-8-81 Aztec Drilling (Rig #50) spudded a 12-1/4" hole at 6:00 p.m. Drilled to a TD of 705' and ran 8-5/8" casing set at 705'. Cemented with 500 SX Class H cement. Plugged down 2:00 p.m. 3-10-81. Circulated 196 SX. WOC 18 hrs. Tested casing with 800# for 30 min. Test OK. Reduced hole to 7-7/8" and resumed drilling. Drilled to a TD of 3132' and ran 5-1/2" casing set at 3132'. Cemented with 700 SX Class H cement. Plugged down 11:00 p.m. 3-14-81. Circulated 180 SX. Currently waiting on completion unit. (TD is 472' deeper than was permitted.)
